LPE plays a significant role in promoting Registered Apprenticeship (RA) programs for the early childhood education (ECE) workforce as an Industry Intermediary. In addition to providing outreach and technical assistance, the LPE team contributes to project management, RA subject matter expertise, and project coordination. LPE supports developing, registering, and launching high-quality, supportive, and equitable RA programs. LPE leads the outreach and education to communicate the economic imperative of early childhood education to all industries and how RA is a strategy to uplift the ECE workforce.

LPE successfully transitioned the MSAP Center into the Schools TA Center, expanding its technical assistance reach to 97 MSAP and FDS grantees and the broader public. This transition included launching a tailored support model that offers personalized virtual assistance, updated toolkits, webinars, and cohort conversations, while also guiding prospective grantees through the application process. As part of this effort, LPE assumed full management of the MSAP Center website, maintaining both its public-facing resources and a secure private section for grantee reporting. We also convened a Technical Working Group (TWG) of 12 national experts in school integration, facilitating strategic discussions and implementing a communication cycle to ensure their input shaped ongoing support. To inform our approach, we conducted a comprehensive needs assessment through focus groups, one-on-one interviews, surveys with a 60% response rate, and document reviews, resulting in a data-driven technical assistance plan.

LPE provides comprehensive logistical and planning support for meetings, trainings, workshops, and conferences of various sizes and scopes. LPE coordinates and delivers a range of administrative services through Subject Matter Experts (SMEs) and consultants, assisting with the development and production of written meeting materials, expert analyses, publications, reports, and multimedia products aligned with SAMHSA's program priorities and initiatives.

LPE manages the logistical planning and support for meetings, materials development, and event coordination, including the planning, organization, and execution of CSAP-sponsored or co-hosted events. These events range from small professional meetings to large-scale trainings, conferences, and virtual engagements such as webinars and podcasts, spanning the entire contract lifecycle.
